11. Manuscriptology


Degree Courses

If less than 15 students are admitted in any course, they may be transferred to the nearest KRC offering the same course and having more than 15 students and vacancy strength. For such transfer the University may invite option but the option will not be binding on the University.

If your Institute fails to take Admission in the above noted courses for two consecutive academic sessions, MoU will stand cancelled and the letter of permission will be null and void.

MEMORANDUM OF UNDERSTANDING (MoU)

This Memorandum of Understanding (MoU) between MMHA&P University and **P.N.S. Institute Of Technology & Management, Bhikhanpura , Muzffarpur** is with regards to acceptance of terms and conditions for the conduct of Academic Programme of Maulana Mazharul Haque Arabic and Persian University. Name of Academic Programme:-

- i) The objective of this MoU is to bring about innovative methods of teaching and learning by sharing available resources with different organizations, so that the benefit of quality teaching is provided to the disadvantage as and deprived sections of students. Such MoUs will be within the limitations of the Bihar University Act 1976 (a) amended up to date.
- ii) Resolved that Maulana Mazharul Haque Arabic and Persian University and **P.N.S. Institute Of Technology & Management, Bhikhanpura , Muzffarpur** will co-operate and collaborate through sharing of resources for the conduct of mutually agreed academic programmes of the University.
- iii) Both Institutions agree to share their physical infrastructure, human resource, teaching and learning material within the objectives and limitations of their own act and statute, if any as well as any rule or regulation.
- iv) The academic programme of Maulana Mazharul Haque Arabic and Persian University such as Degree, Diploma, Advanced Diploma Courses as well as Certificate courses shall be conducted jointly in accordance with mutual understanding without putting any financial burden upon the University but the University may meet such financial burden with the approval of the finance committee or any other competent authority of the University and the Governing body/ managing committee/ Executive council/ committee of the institution with whose collaboration the academic programme of the University shall be carried out.
- v) **P.N.S. Institute Of Technology & Management, Bhikhanpura , Muzffarpur** will be providing the necessary Library, Laboratory facilities if available to the enrolled student/ Researchers on payment of free of cost as decided by the Executive Council/ Governing body of the Organization.
- vi) In no case the University or the collaborating organization will take the liability of appointment absorbing any of the staff members engaged in the conduct of the courses. Staff requirement of any course will be decided by the University and they will be engaged as per the rule of the University.
- vii) Both the parties agree to conduct the Academic programme jointly and Diploma/ Degree Certificate will be awarded by the University as per the approved Ordinance/ Regulations.
- viii) This MoU is signed between Maulana Mazharul Haque Arabic and Persian University and --- **P.N.S. Institute Of Technology & Management, Bhikhanpura , Muzffarpur** on 29th July 2016 in the interest of educational development in the State.
- ix) The University shall reimburse the cost of teaching learning material out of the fee collected subject to a maximum amount of 70% of the total net income.
- x) Modalities of admission will be decided by the University for each course as per its Admission Ordinance and/ or decision of the University.
- xi) The **P.N.S. Institute Of Technology & Management, Bhikhanpura , Muzffarpur** agrees to make available its Library to the students enrolled in Voc. Courses.
- xii) Academic Programme will follow the approved Ordinance/ Regulation of the University. Such terms and conditions including Regulation/ Ordinance shall be subject to change and/ or amendment.
